WAIVERS: Two waivers are required: this one, which includes your age and USATF membership number, and one required by Cal. Please bring these with you to expedite registration.

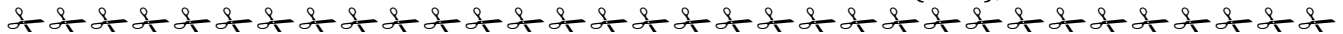
Registration: Opens at 7:30 a.m.; please register by on the east side of the stadium before 9:30 a.m.
